¹ Situations where form of trafficking is "Other/Not Specified" typically occur when a law enforcement agent or service provider contacts the Trafficking Hotline for resources and referrals but does not disclose details about the trafficking situation due to confidentiality. This category also includes incidents in which the person reporting the information references human trafficking but does not provide further detail regarding the presence of labor or commercial sex. These cases are often submitted to the Trafficking Hotline through anonymous online tip reports.

² Situations where the trafficking type is No Type typically occur when the person reporting the information references either a specific form of trafficking but does not provide further detail regarding the business structure or operation of the trafficking situation, or does not provide any information regarding the form of trafficking information due to confidentiality.

This table shows a breakdown of incidents by their Type as defined in Polaris's report, **Typology of Modern Slavery: Defining Sex and Labor Trafficking in the United States.** Note that while Type of trafficking is similar to the Venue/Industry values on the Trafficking Hotline website, there are some differences and so values may not perfectly match.

Polaris uses the federal standard of 18 as the age of majority for all situations regardless of the laws in specific jurisdictions. All likely victims included as minors were reported by individuals with a high degree of confidence regarding the likely victim's age. Given the significance of whether a likely victim is an adult or minor, if the actual age is unknown and the apparent age is close to the adult/minor boundary (ex. a likely victim is described as being 16-20), **Unknown** is selected.

Age at Entry into Exploitation

"Age at Entry into Exploitation" refers to the age of likely victims when the first commercial sex act or the first time initiating labor/services occurred. This should not be confused with the age the likely victim was when they first contacted the Trafficking Hotline (Age at First Contact with Polaris).

Force, Fraud, and Coercion (grouped)

"Force, Fraud, and Coercion" refers to the methods of control and abuse frequently employed by traffickers to compel a likely victim to remain in the trafficking situation. These tables group more specific methods of FFC into their overarching categories for ease of analysis:

- Economic Abuse includes, but is not limited to: taking/withholding earnings, limiting access to finances, blacklisting (or threatening to), and debts/quotas.
- Emotional Abuse includes, but is not limited to: verbal abuse or manipulation, familial-based emotional abuse, and intimate partner-based emotional abuse.
- Intimidation includes, but is not limited to: destruction of property, harming others or animals, and displaying weapons.
- Isolation includes, but is not limited to: limiting access to support systems, controlling in public, confinement, and limiting access to medical services.
- Threats include, but are not limited to: threats to harm the likely victim, their family, or others, threats to expose or shame the likely victim, threats to report to immigration/threats of deportation, and threats to report to law enforcement.

The data displayed in this report was generated based on information communicated to the National Human Trafficking Hotline via phone, email, online tip report, SMS, or Webchat. The National Human Trafficking Hotline cannot verify the accuracy of the information reported. This is not a comprehensive report on the scale or scope of human trafficking within the United States. These statistics are accurate as of 07/01/2021, but are subject to change as new information emerges or as data cleanup occurs.

Since awareness of both human trafficking and the existence of a national victim service hotline is still limited, this data set should be interpreted as a limited sample of actual victim or trafficking incident data, rather than a representation of all existent victims or incidents of human trafficking. The information reported by the Trafficking Hotline is only able to represent who has access to and knowledge of the Trafficking Hotline, who has the means to reach out, and who is more likely to self-identify as a likely victim or someone in need of assistance.
